Dear Provider,

Please see below for additional information on the updates to the timeline for the 2019 HPSM Primary Care Benchmark Pay for Performance Program deadlines.

The following information was sent out in a previous provider notice on 4/8/2020: In response to the current public health emergency HPSM is revising our timeline for the 2019 Medi-Cal HPSM Benchmark P4P Program deadlines for final payment calculation as follows:

Item	Original Deadline	New Deadline
Claims data submission for numerator credit (dates of service in 2019)	March 31, 2020	April 30, 2020
Manual data submission for eligible measure attestation	April 30, 2020	June 15, 2020

As a follow-up to our prior notice, please see below for an overview of the submission process for participating providers who wish to send manual attestations for eligible 2019 Benchmark Pay for Performance measures.

2019 Benchmark P4P measures eligible for manual attestation:

- 1. Adolescent Immunizations
- 2. Cervical Cancer Screening
- 3. Child Immunizations
- 4. Initial Health Assessments
- 5. Mammogram for Breast Cancer Screening

Attestation Submission Instructions:

1. Login and download the May 2020 Benchmark P4P Member Detail Report (excel file) for your clinic in the HPSM eReports portal:

- 2. In the excel file, add a column labeled 'Attestation' to the right of the column for the measure you are submitting attestation data for.
- 3. In the Attestation column add the date of service you are attesting to for compliance for the measure.
- 4. Any services attested to through the HPSM P4P attestation process must have supporting documentation in the patient's medical record. HPSM may request this documentation for program auditing purposes at any time. This information must be made available to HPSM within 30 calendar days upon request at no cost to HPSM.
- 5. The attestation report must be sent securely to <u>molly.carter@hpsm.org</u> by 6/15/2020 to be considered toward additional 2019 Benchmark P4P credit.
