This notice is to update you on several items related to ongoing COVID-19 response activities. Please see below for the items covered in this notice.

1. Medi-Cal Primary Care Capitation Telehealth Carve-Out

Effective for dates of service on and after 4/1/2020 until further notice: To further support our provider community with the necessary adjustments during this time and to align with the guidance to increase the use of telemedicine when appropriate, including telehealth services, HPSM will pay fee for service in addition to primary care capitation for services provided via telehealth until further notice based on the following criteria:

- Procedure code is currently listed in the scope of Medi-Cal primary care capitation
- Procedure code is billed using place of service code 02
- Member is assigned to the PCP on the date of service and the service would have otherwise been capitated

These services will be reimbursed at 100% of the Medi-Cal fee schedule in addition to primary care capitation.

*Please note: all non-capitated services and non-assigned member visits will continue to be paid fee for service as before, including telemedicine services.

2. 2019 Medi-Cal HPSM Benchmark Pay for Performance (P4P) Program Updates

In response to the current public health emergency HPSM is revising our timeline for the 2019 Medi-Cal HPSM Benchmark P4P Program deadlines for final payment calculation as follows:

Item	Original Deadline	New Deadline
Claims data submission for numerator credit (dates of service in 2019)	March 31, 2020	April 30, 2020
Manual data submission for eligible measure attestation	April 30, 2020	June 15, 2020
Estimated 2019 payment release	Late May/Early June	Late June/Early July

We will send a separate notice soon on the details for the upcoming manual data attestation process for final 2019 P4P payment calculations.

3. Routine Childhood Immunizations during COVID-19 Pandemic

On 3/27/2020, the following guidance was issued by the California Department of Public Health related to the California Vaccines for Children (VFC) Program:

Because of personal, practice, or community circumstances related to COVID-19, some providers may not be able to provide well child visits, including provision of immunizations, for all patients in their practice.

 If a practice can provide only limited well child visits, healthcare providers are encouraged to prioritize newborn care and vaccination of infants and young children (through 24 months of age) when possible.
