requires custom coding, volume-based Benchmark P4P: Population outcomes, measured from claims, value-based

Benchmark P4P Program Highlights



- 2018 = Implementation/Baseline year
 - Absolute quality benchmarks only to measure performance in the baseline year
- 7 quality measures per clinic
 - 3 assigned by HPSM
 - Depends on clinic patient population age range pediatrics vs. adult
 - 4 chosen by the clinic
 - From 2018 Benchmark P4P measure set

Benchmark P4P Program Highlights



- Full credit benchmark:
 - If HEDIS: 75th percentile
 - If HPSM: See guidelines/outline
- Partial credit benchmark:
 - If HEDIS: 50th percentile
 - If HPSM: See guidelines/outline

*Since this is the baseline year there is no improvement target but that will be added in future program years


- No alternative procedure codes!





Sample Benchmark Measure Definition:



Depression screening and follow-up

Patient Eligibility: Patients 12 years old and up

Full Credit: 75% Partial Credit: 60%

Measure Definition: The percentage of patients 12 year of age and older who had an annual depression screening using a standard depression screening tool (including HPSM Behavioral Health Screening tool available at: <u>www.hpsm.org/providers/medi-cal-p4p.aspx</u>, which includes PHQ-2 standard screening questions)

- Screening must be documented in patient's medical record
- If screening is positive, follow-up plan must be documented

Sample Benchmark Measure Definition:



Comprehensive Diabetes Care

Patient Eligibility: Patients 18 years old and up with a diagnosis of diabetes

Full Credit: 50% Partial Credit: 40%

Measure Definition: Percent of assigned diabetic patients who had at least one HbA1c test and result submitted to HPSM, an eye exam, blood pressure reading, and medical attention for nephropathy or screening in the current program (calendar) year.

*See diabetes measure definitions for full list of requirements and procedure codes.

Sample Benchmark Measure Definition:



Asthma Medication Ratio

Patient Eligibility: Patients 5–64 years of age who were identified as having persistent asthma

Full Credit Benchmark: 67.45% Partial Credit Benchmark: 62.19%

Measure Definition: The percentage of members 5–64 years of age who were identified as having persistent asthma and had a ratio of controller medications to total asthma medications of 0.50 or greater during the calendar year.

We want your input! Two payment options for Benchmark P4P

Annual Payment Option:

- Annual lump sum bonus payment in April following the program (calendar) year
 - i.e. first payment in April 2019 for 2018 performance
- Additional bonus for reaching all full-credit benchmarks

Monthly Payment Option:

- Portion of potential total paid monthly through capitation
- Year-end reconciliation based on annual performance
 - Remaining amount paid out or
 - Potentially give some back
- Additional bonus for reaching all full-credit benchmarks at year-end reconciliation

Benchmark P4P Payment Methodology:



Payment Equation:

Member Points: Average Member Months*Composite Quality Score

Total Payment: Member Points*\$PMPM

*Additional bonus at year-end if all fullcredit quality benchmarks have been met
